# Status of Building Code Allowances for Tall Mass Timber in the IBC

Jurisdictions that have adopted the tall mass timber code provisions in the 2021 and/or 2024 IBC International Building Code (IBC), either in whole or with local amendments.



## Status as of January 2025

The 2021 International Building Code (IBC) and 2024 IBC are published and available from the International Code Council. These versions of the code include three new construction types—IV-A, IV-B and IV-C—that allow the use of mass timber or noncombustible materials in buildings up to 18, 12 and nine stories (respectively). One significant change of the 2024 IBC from the 2021 IBC is related to the allowance for exposure of mass timber ceilings and integral beams in type IV-B construction. The 2021 IBC permits these areas

to have 20% exposure while the 2024 IBC permits 100% exposure. See the full code language in IBC section 602.4.2.2 For additional information on this topic, [see this WoodWorks expert tip](#).

The following states have adopted the tall mass timber provisions of the 2021 and/or 2024 IBC, either whole or with local amendments. Additional local jurisdictions have adopted the mass timber provisions in advance of statewide adoption and it is always recommended to check with the jurisdiction of the project for what requirements apply to planned construction.
